A Resolution Approving and Ratifying the Terms of a Real Property Tax Appeal Settlement Between the City of Somers Point and Harbour Cove Marina, LLC For Property Designated as Block 1211 / Lot 2

# SPONSORED BY: Council President McGuigan

Whereas, there have been pending before the New Jersey Tax Court a series of real estate tax appeals filed against the City as Defendant by Harbour Cove Marina, LLC as Plaintiff, for tax years 2009 through 2013; and

Whereas, a stipulation of settlement was prepared and executed by the parties in April of 2014; and

Whereas, subsequent thereto a dispute arose between the parties concerning the terms of the settlement; and

Whereas, a motion was filed by Plaintiff to set aside the settlement and proceed to trial on the subject appeals; and

Whereas, an order had been entered by the Tax Court precluding the City Tax Collector from holding a real estate tax sale; and

Whereas, motion was filed on behalf of the City to vacate that prior order, to authorize the Tax Collector to proceed with a property tax sale and to dismiss Plaintiff's motion to set aside the prior Settlement; and

Whereas, negotiations have been held between the parties and court hearings have been held before Judge Michael J. Gilmore on December 14, December 19, and December 22, 2017; and

Whereas, the settlement terms were reviewed with the City Tax Collector, City Administrator and with City Council during an Executive Sessions held on November 20 and December 14, 2017; and

Whereas, an Order embodying the terms of the settlement was issued by the Tax Court on December 22, 2017 subject to formal approval by Council Resolution on January 11, 2018.

Now, therefore, it is hereby Resolved by the City Council of the City of Somers Point that the following terms of settlement set forth in the December 22, 2017 Order of the Tax Court are hereby approved and ratified:

- 1) The Plaintiff's Motion to set aside the prior settlement, vacate the judgments entered, enjoin any property tax sale proceeding and to proceed to trial on the 2009-2013 tax appeals will be dismissed with prejudice;
- 2) The payment to the City by Plaintiff in the amount of Four Hundred Thousand Dollars made on December 22, 2017 is accepted in full satisfaction of any and all outstanding property taxes, interest, penalties and any other charges associated with tax assessments on the subject property due through December 31, 2017;
- 3) Any interest and late fee penalties in excess of Four Hundred Thousand Dollars is waived;
- 4) The 2017 property assessment in the aggregate amount of \$3,250.000 (\$1,975,000 Land and \$1,275,000 Improvements) upon the Plaintiff's property (Block 1211 / Lot 2) with an address of 520 Bay Avenue is affirmed;
- 5) No refunds, credits or other payments are to be made by the City to Plaintiff;
- 6) The Order precluding the City Tax Collector from conducting a property tax sale is vacated; and
- 7) The property tax sale which was postponed from December 22, 2017 shall be cancelled.
