Subject: Concurring with the Establishment of a Formal Fund Balance Policy Proposed by: Council President McGuigan and Councilmen Dill and Gerety

**WHEREAS,** a formal Fund Balance Policy of the City of Somers Point was established by the City Administrator on May 5, 2013 and later amended on April 22, 2014; and

**WHEREAS,** the City Council of the City of Somers Point desires to confirm its concurrence with the policy as currently presented by the City Administrator.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Somers Point hereby concurs with and adopts the following policy:

### Fund Balance Policy

The City of Somers Point recognizes that, in general, a significant portion of the current year fund balance is generated by the operations of the immediate previous year.

Because of that, the current year taxpayers, who are most likely the closest group possible to the previous year's taxpayers, deserve the greatest consideration when using surplus as a revenue source, thus reducing the necessary amount to be raised by taxation in the current year budget.

Nonetheless, the use of surplus as a revenue source to reduce the amount to be raised by taxation needs to be balanced against the long term fiscal position of the City.

It is the goal of the City to continually reduce reliance on surplus to offset the tax rate by maximizing the collection of all other available, appropriate revenues.

Unless unusual circumstances warrant otherwise, the City will attempt to limit the use of the available surplus as a budget revenue source to less than 10% of the total current fund budget amount, and maintain a minimum surplus balance of 2% to 3% of the current year budget total in addition to the amount utilized as a budget revenue.

The Chief Financial Officer will maintain a schedule of at least a five-year record of the use of surplus in the budget and provide that information to City Council, or the appropriate City Council Committee, and review that information along with surplus usage trends, during the annual budget process.
