Committee Reports

Councilman Dill reported heavy flooding due to a storm and high tides. The worse flooding was located at Bay Avenue, Decatur Avenue and New York Avenue. There are two issues regarding the flooding. City Engineer, Greg Snyder, explained to the Governing Body that an old outfall pipe near New York Avenue and Bay Avenue is capped with no check valve, which is no longer needed and could be filled in. The quotes came in at approximately \$2,500.00 and the work should be completed next week. The Code Enforcement Officer has determined that the privately owned bulkhead is not structurally sound and must be replaced and raised by 2 feet according to the City Code. AN ORDINANCE REPEALING ORDINANCE 27 OF 2015

WHEREAS, , a Community Block Development Grant had been obtained by the City of Somers Point to correct a drainage problem existing on certain properties located within Block 510 as designated on the Tax Map of the City of Somers Point (the "Project"); and

WHEREAS, the City did obtain a Community Development Block Grant to fund the Project; and

WHEREAS, the City Engineer prepared plans and specifications for the project which required drainage easements to be granted by certain owners of property within Block 510: and

WHEREAS, City Council adopted Ordinance 27 of 2015 authorizing the City to obtain the necessary drainage easements; and

WHEREAS, on November 10, 2015 bids were received for the Project which were far in excess of both the Engineer's estimate and the funds available for the Project; and

WHEREAS, as a result, the bids were rejected; and

WHEREAS, there is no need for the City to acquire the drainage easements which would have been necessary to construct the Project as designed

Now, therefore, it is hereby ORDAINED by the Common Council of the City of Somers Point as follows:

- **SECTION 1:** Ordinance 27 of 2015 is hereby repealed in its entirety and shall be of no further force and effect.
- **SECTION 2**: All Ordinances or portions thereof inconsistent with this Ordinance are repealed to the extent of such inconsistency.

Whereas, by letter dated August 8, 2014. a request was made to the City of Somers Point by New Jersey Transit, a State - owned public transportation system ("NJT") to review NJT's recommended locations for designated bus stops along State Highway Route 9 ("Rt. 9) within the City of Somers Point; and

Whereas, a review of the proposed locations was undertaken by the City Engineer and the City's Traffic Safety Officer; and

Whereas, by response to NJT dated March 31, 2015 a Municipal Review Statement was submitted on behalf of the City to NJT with suggested locations; and

Whereas, NJT submitted the Municipal Review Statement to the New Jersey Department of Transportation ("NJDOT") to investigate the feasibility of locating bus stops at the proposed locations along Rt. 9; and

Whereas, by letter dated August 19, 2015, NJDOT submitted a list of approved locations which modified the locations submitted by the City and NJT; and

Whereas, the City Engineer has reviewed the revised locations which have been designated and approved by NJDOT; and

Whereas, in order to legally establish the designated bus stops the NJDOT is required to promulgate a Traffic Regulation Order ("TRO"); and

Whereas, in order to promulgate the TRO the NJDOT requires the City Council to adopt a Resolution of Support

Now, therefore, it is hereby resolved that the governing body of the City of Somers Point approves the following bus stop locations which have been designated by the NJDOT:

1) Along Route US 9 (New Road), northbound, on the easterly side at:

A. Rhode Island Avenue (near side)

Beginning at the southerly curb line of Rhode Island Avenue and extending 105 feet southerly therefrom;

B. Massachusetts Avenue (near side)

Beginning at the southerly curb line of Massachusetts Avenue and extending 105 feet southerly therefrom;

C. Between Chapman Boulevard and Bethel Road (midblock)

Beginning at a point 165 feet north of the prolongation of the northerly curb line of Chapman Boulevard and extending 135 feet northerly therefrom;

2. Along Route US 9 (New Road), southbound, on the westerly side at:

A. Ocean Heights Avenue (CR 559A) (far side)

Beginning at the southerly curb line of Ocean Heights Avenue and extending 140 feet southerly therefrom;

B. Between Chapman Boulevard and Groveland Avenue (midblock)

Beginning at a point 265 feet south of the southerly curb line of Chapman Boulevard and extending 135 feet southerly therefrom;

C. Massachusetts Avenue (near side)

Beginning at the northerly curb line of Massachusetts Avenue and extending 105 feet northerly therefrom;

D. Between Connecticut Avenue and New York Avenue (midblock)

Beginning at a point 85 feet south of the southerly curb line of Connecticut Avenue and extending 135 feet southerly therefrom.

It is further Resolved that any previously approved bus stop locations or traffic regulations promulgated by the City which are in conflict with or inconsistent with the provisions of this Resolution shall be rescinded upon issuance of the Traffic Regulation by NJDOT; and

It is further, Resolved that the City Clerk is requested to send a certified copy of this Resolution to the New Jersey Department of Transportation and New Jersey Transit with a request to NJDOT to provide to the City Clerk a certified copy of the Traffic Regulation Order when promulgated.
