"(5) Any matter involving the purchase lease or acquisition of real property with public funds, the setting of bank rates or investment of public funds where it could adversely affect the public interest if discussion of such matters were disclosed."

The nature of the matters, described as specifically as possible without undermining the need for confidentiality are:

- 1) Acquisition of land necessary for recreational use to extend the Bike Path for which the exercise of eminent domain has been authorized, if needed; and
- 2) Potential acquisition of land necessary for public use by the City.

"(7) Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer."

The nature of the discussion, described as specifically as possible without undermining the need for confidentiality is to engage in a full and thorough discussion with the City Solicitor, City Engineer and City Administrator.

WHEREAS, the length of the Executive Session is estimated to be approximately 45 - 60 minutes after which the public meeting of the City Council shall reconvene;

WHEREAS, current law allows for real property tax appeals to be filed directly with the New Jersey Tax Court where the assessed value of the real estate is at least One Million Dollars (\$1,000,000.00) or such tax appeals may be filed initially with the County Board of Taxation from whose decision an appeal may be taken to the. Tax Court; and

WHEREAS, particularly in those cases where a commercial property is the subject of the tax appeal, due to delay on the part of the owner of the commercial property there is unnecessary time, effort and expense incurred by the Municipal Tax Assessor and the Municipality's Tax Appeal attorney when the owner's Appraisal of the real property is not submitted to the municipality in a timely manner; and

WHEREAS, there is pending in the State Legislature a Bill sponsored by Assemblyman Patrick J. Diegnan, Jr. which will mandate that in all appeals filed in the New Jersey Tax Court the owner's appraisal must be submitted to the municipality within ninety (90) days following filing of the appeal if the assessed value of the real property is in excess of One Million Dollars;

WHEREAS, the bill further provides that absent a showing of good cause for failing to file the appraisal within the time required the appeal shall be dismissed with prejudice; and

WHEREAS, the bill has been favorably reported out of the Assembly State and Local Government Committee; and

WHEREAS, enactment of A3351 will greatly benefit municipalities by expediting commercial tax appeals which can drag on for years, may reduce the backlog of commercial cases pending in the Tax Court, and should reduce the fees and costs incurred by municipalities to defend against such tax appeals.

WHEREAS, in these times of fiscal restraint such monies should be better spent on more worthwhile endeavors; and

WHEREAS, the Governing Body of the City of Somers Point believes that such legislation is in the best interest of the citizens of the State of New Jersey and of the municipalities situated herein

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Governing Body of the City of Somers Point supports enactment of A-3351.

WHEREAS, in a decision rendered in 1991 the Supreme Court of New Jersey in the matter of Devins v. Borough of Bogota 124 N.J. 570 reversed the long standing rule that municipally owned property could not be subject to acquisition by adverse possession; and

WHEREAS, in rendering their decision, recognizing the wide spread impact such a ruling would have upon governmental entities, the Supreme Court further held that the impact of their decision would not become effective until twenty (20) years after their decision had been rendered; and

WHEREAS, the twenty year grace period expired in 2011; and

WHEREAS, within the twenty years since the Supreme Court rendered its decision the Legislature has not enacted any Law to restore the long standing rule that government owned property cannot be acquired by adverse possession; and

WHEREAS, in 2010 Assembly Bill No. 1681 was introduced on January 12, 2010 to cure this deficiency and protect government entities from wrongful seizure of publicly owned properties; and

WHEREAS, following introduction A1681 was referred to the Assembly Transportation, Public Works and Independent Authorities Committee from which it was never released; and

WHEREAS, unless Legislative action is taken, Municipalities and other governmental entities will not only be subject to taking by adverse possession but in order to prevent such wrongful taking, may be obligated to spend considerable public funds to identify incidents of adverse possession which may exist in order to protect the public interest and incur legal fees which would otherwise not be necessary; and

WHEREAS, in these times of fiscal restraint such monies should be better spent on more worthwhile projects; and

WHEREAS, the Governing Body of the City of Somers Point believes that such legislation is in the best interest of the citizens of the State of New Jersey and of the municipalities and counties situated herein; and

WHEREAS, S2143 sponsored by Senator Jeff Van Drew and companion bill A3547/A1682 Cosponsored by Assemblyman Bob Andrzejczak, Assemblyman Jay Webber, and Assemblyman John S. Wisniewski as Primary Sponsors and Assemblyman Erik Peterson as Co-Sponsor.

WHEREAS, the following language is contained in S2143 and A3547/A1682:

"Except as provided in section 3 of P.L., c. (C.) (pending before the Legislature as this bill), this act shall not limit the estate, right, title or interest of, or bar any claim or action by:

a. The State, any agency thereof, or any political subdivision of the State, including, but not limited to, its instrumentalities and independent authorities, or any county or municipality, or any agency or authority of a county or municipality, with respect to real property or any estate, right, title or interest therein, that was at any time used or intended to be used for a public or transportation, environmental, recreational, governmental, educational, charitable, institutional or other similar purpose or held in public trust, whether such use be at the time of acquisition or sometime thereafter..."; and

WHEREAS, A1681 pre-filed for introduction in the 2010 Session contained the following language:

- "1. a. Notwithstanding any other provision of law, title to real property owned by the State, any agency thereof, or any political subdivision of the State, whether or not the real property is dedicated to or used for a public purpose, cannot be acquired by adverse possession. Actions brought by the State, any agency thereof, or any political subdivision of this State for the recovery of any publicly owned real property shall not be time-barred.
- b. As used in this act, "real property' shall mean lands, structures, franchises and interests in land, including air space and air rights, waters, lands under water and riparian rights, and any and all things and rights encompassed by the said term, and includes, not only fees simple absolute but also any and all lesser interests, including, but not limited to easements, rights of way, uses, leases and licenses."; and

Although the intent may be the same, in order to avoid any ambiguity it is respectfully requested that the Sponsors and Co-Sponsor give serious consideration to amending the pending legislation to incorporate the language contained in A1681 as set forth above although modified to the extent necessary to preserve the tidal flow exception set forth in S2143 and A3547/A1682.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Governing Body of the City of Somers Point supports enactment of Legislation comparable which would preclude the taking of government owned property through adverse possession and would further provide that actions brought by any governmental entity for recovery of any such property not be time barred; and
