**Introduced by:** Mayor and City Council

**WHEREAS**, Congressman Rogers of Michigan, Chairman of the House of Representatives Select Committee on Intelligence (for himself and Congressman LoBiondo) has introduced HR 1497; and

**WHEREAS**, HR 1497 would direct the Secretary of Defense to take whatever steps may be necessary to exhume and transfer the remains of certain deceased members of the Armed Forces buried in Tripoli, Libya; and

**WHEREAS**, the City of Somers Point has for decades attempted to bring home its favorite son, United States Navy Master Commandant Richard Somers who died a hero's death in the battle of Tripoli Harbor on September 4, 1804 and remains buried in a mass grave with his twelve -man crew of the USS Intrepid in Tripoli, Libya, not far from where he died; and

WHEREAS, Richard Somers has been memorialized by the United States Navy and there have been at least six Naval warships named after him, as well as a monument erected which now stands at the United States Naval Academy in Annapolis, Maryland, and the heroic actions of Commandant Somers helped inspire the line in the Marine Corps anthem "From the halls of Montezuma to the shores of Tripoli": and

**WHEREAS,** it is the tradition of our United States Marine Corps to not leave our dead and wounded behind, yet the remains of Commandant Somers and his crew are still buried in Tripoli, Libya where they died defending our County; and

**WHEREAS**, on June 24, 2004 the New Jersey State Legislature unanimously passed Assembly Resolution 121 requesting the Secretary of State to open negotiations with Libyan leaders for the repatriation of Commandant Richard Somers and his crew prior to the 200<sup>th</sup> anniversary of his death on September 4, 2004; and

**WHEREAS**, after 207 years, it is time to bring Commandant Richard Somers and his crew of volunteers back to the United States of America where they can be welcomed home and be buried like the true American heroes that they are.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Somers Point hereby urges the passage of HR 1497 which would direct the Secretary of Defense to take whatever steps may be necessary to exhume and transfer the remains, finally beginning the process of honoring the American Heroes who bravely died for their country on the USS Intrepid by bringing them home for proper internment in United States ground.
